United States. They were allowed exchange as
directed by the War Department. Previous to
their leaving the prison they had been
quarantined in the Hospital. The authority had
been given by the War Department, which the pris-
oners were permitted to take the oath of Al-
legiance to the United States and for their homes,
which they did.
